## Construction of CCSPC Vehicle Parking Shade

PhilGEPS Reference #4655991

1. The *Cotabato City State Polytechnic College*, through the *Government Appropriation Act FY 2017*<sup>1</sup> intends to apply the sum of *One Million One Hundred Thousand Pesos (P1,100,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Construction of CCSPC Vehicle Parking Shade*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Cotabato City State Polytechnic College* now invites bids for the *Construction of CCSPC Vehicle Parking Shade*.<sup>2</sup> Completion of the Works is required *within two (2) months or 60 calendar days*. They must have completed within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Cotabato City State Polytechnic College* and inspect the Bidding Documents at the address given below from *8:00a.m-5:00pm Monday-Friday*.
5. A complete set of Bidding Documents may be acquired by interested bidders on from the address below *and upon payment of Five Thousand Pesos (P5,000.00.)*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Cotabato City State Polytechnic College* will hold a Pre-Bid Conference<sup>3</sup> on July 27, 2017 at 9:00 a.m., *e-building conference room, CCSPC Campus, Cotabato City* which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before 1:30pm of August 09, 2017. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.  
  
Bid opening shall be on August 09, 2017 at 1:30p.m at *e-building conference room, CCSPC Campus, Cotabato City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The *Cotabato City State Polytechnic College* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
